

Main Street Festival 2025 Rules & Regulations

APPLICATIONS:

- The Wellsville Area Chamber of Commerce reserves the right to refuse any vendor application and/or re-categorize vendor type.
- Spaces are assigned on a first come, first serve basis. Requests can and will be taken into consideration but may not be honored due to unforeseen circumstances. Event space is limited and once the event is full, applications will not be accepted.
- Event Permit – **NEW for 2025**, Vendors will receive an Event Permit when they receive their vendor space number. Vendors are to sign the permit and bring a copy with them to the event. Any vendor set-up that does not have an Event Permit, will be asked to leave by the police.
- Electricity is limited and there will be a \$25.00 fee if needed.
- Depending on product, you may need proof of insurance. Food vendors for example.
- Vendor tents, tables and products must fit in a 10x10 booth space unless you purchase additional space.
- Political or offensive products are not allowed – this is a family event.**
- No refunds will be given.
- Once your application, payment and copy of your insurance (if required) are received and accepted you will receive an email confirmation.
- NOTE: You will receive your vendor space number and map approximately 5 days prior to event.

SET-UP / TEAR-DOWN:

- Use only Main Street for loading and unloading.
- Set up time is between 7:00am and 8:15am on Saturday July 19, 2025. No vehicles on street after 8:15am. No exceptions.
- You must unload at your assigned space and move your vehicle off Main Street before setting up your booth. Park in authorized parking lots legally.
- You must man your booth from 9:00am to 4:00pm. No early tear downs.
- Sales end at 4:00pm. You must tear down and vacate Main Street by 5:00pm.
- All garbage must be removed from booth space and disposed of properly.

EVENT:

- Children under 14 must have adult supervision.
- No rain dates.
- No dogs or smoking/vaping permitted.
- The Wellsville Area Chamber of Commerce and The Village Events are not responsible for any theft or damage.
- Failure to abide by our Rules & Regulations will result in vendors not being allowed at future events.

MURAL PROJECT

As part of the Wellsville Area Chamber of Commerce's 100-Year Anniversary Celebration, the Chamber commissioned a "WELLSVILLE" mural that is currently being painted on the side of L'Italia (105 N Main St, Wellsville, NY); adding vibrancy and energy to our community through art. Due to the overwhelming support for the mural, a second phase has been commissioned doubling the size of the mural and adding additional Wellsville landmarks.

The artist, Corinn Marriott, began work on the mural August 2024 and will resume work once the weather breaks. The mural should be completed by July 2025, and we plan on holding a ribbon cutting ceremony.

Checks can be made out to the Wellsville Development Corporation, the Chamber's affiliated 501(c)(3) not-for-profit, and are tax deductible.


